SUBSCRIBERS LIST**

The above subject is duly referred.

2. Firstly, Port Klang Authority (PKA) would like to express our appreciation to Shipping Lines / Agents / NVOCCs / Box Operators on the support rendered in opting for the alternative solutions to container deposit collection. We certainly believe the alternative will ease the financial burdens of Importers and their Agents and reduce the cost of doing business in Port Klang.
3. As stipulated in PKA's General Manager Circular No. 2/2020 dated 21 February 2020, Shipping Lines / Agents / NVOCCs / Box Operators shall no longer collect container deposits from Freight Forwarders / Forwarding Agents whom have subscribed to the alternative solutions as well. However, container deposit can be collected from Freight Forwarders / Forwarding Agents whom are not subscribers of the alternative schemes.
4. In order for all industry players to identify the Shipping Lines / Agents / NVOCCs / Box Operators, Freight Forwarders and Forwarding Agents whom have subscribed to these schemes, PKA has set up a portal on our website in which Port Users can access to get the list of subscribers of the scheme. The list of NCD subscribers can be downloaded via the NCDS portal <http://pkapp.pka.gov.my/ncds/ncdregisteredlist.php> whereas CLA subscribers can be downloaded via CLA portal <http://corporate.dnd.com.my/ourClients.php>.


